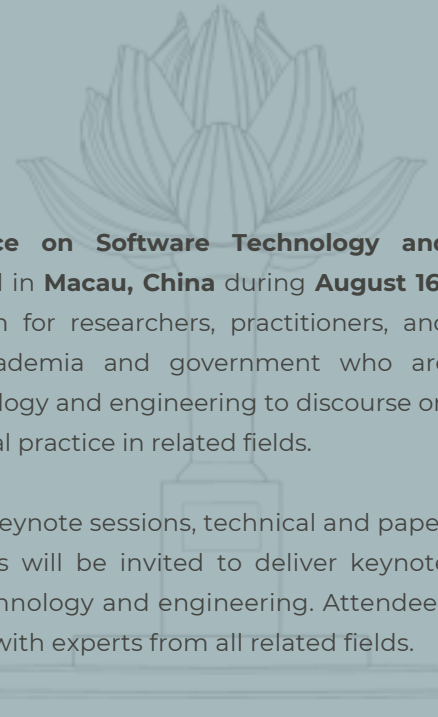

About Macau

Macau is a special administrative region of China, which maintains separate governing and economic systems from those of mainland China under the principle of "one country, two systems". The unique blend of Portuguese and Chinese architecture in the city's historic centre led to its inscription on the UNESCO World Heritage List in 2005. Originally a sparsely populated collection of coastal islands, Macau, often referred to as the "Las Vegas of the East", has become a major resort city and a top destination for gambling tourism, with a gambling industry seven times larger than that of Las Vegas.
